BOND FOR EXCAVATION IN STREETS

Know all men by These Presents, That _____
herein after referred to as Contractor and _____
As Sureties do hereby bind themselves, their heirs, executors and administrators jointly and
severally to the City of Mishawaka herein after referred to as City for payment of five Thousand
Dollars (\$5,000.00).

The condition of this obligation is such; that if the above contractor shall in every detail
execute and complete all work of whatever nature undertaken by them in the streets, alleys and
public right-of-way of said City, whether under private contract with individual property owners
or under contract with said City, to the satisfaction of the Department of Public Works and
according to the general and special specifications adopted by said Department for street work,
and whenever excavations shall be made under permits from said City, shall in making such
excavations under such permits complete the work in a workmanlike manner and shall
thoroughly fill and compact the soil, and shall cause any pavements necessarily removed by such
excavation to be removed from the site and disposed of by contractor and shall immediately
restore pavement and, whatever called upon correct any defect in restoration of an excavation, to
the complete satisfaction of the Department of Public Works of said City, and shall do all work
strictly in accordance with the City Ordinances which are now or may hereafter be in effect, and
the rules and regulations heretofore established, or which may hereafter be established by the
Department of Public Works of said City, and shall at all times faithfully perform all of the
requirements of said Ordinances, Rules and Regulations and all of his duties hereunder including
all notices and payments, and shall forever save said City harmless from any loss or liability
incurred through their fault or that of their agents or employees, then this obligations, shall be
void, otherwise shall remain in full force and effect.

It is agreed between the parties hereto that the term of this bond shall be for a period of
one (1) year beginning with the 1st day of _____ 20 ____, and ending with the 31st day
of December 20_____, and to be renewed by a continuation certificate.

And it is hereby further agreed by said principal and his sureties therein that this bond
shall be a continuing bond as to the work done hereunder and shall obligate all of said parties in
each and every case of all such work done and shall continue to so obligate said parties for the
period of one year after the completion and acceptance of each piece of work as aforesaid and
according the terms of this bond. In the event that said City shall extend time to the above bound
principal, or principals, for the performance of any contract work, or in any work operate to
release the sureties on this Bond.
