DEFINITION: Performs a variety of network-related tasks for the Information Technologies Department.

ESSENTIAL FUNCTIONS OF THE JOB:

1. Serve as the primary administrator for all network services including data, voice, wireless, and VPN networks.
2. Monitor for consistent availability of network services and maintain current network security protocols.
3. Safeguard the network systems by creating and applying policies, along with monitoring access.
4. Administer firewall settings in line with IT security strategy.
5. Participate in business continuity testing and disaster recovery planning.
6. Ability to work independently and manage projects and tasks to a schedule.
7. Support end-user devices such as laptops, desktops, cell phones, VoIP phone systems, door access systems, video surveillance systems, etc.
8. Maintain knowledge and understanding of security and networking best practices
9. Anticipates future network needs, identify proactive solutions to satisfy needs.
10. Obtain and maintain understanding of current and future technology to meet the needs of the department.
11. Extensive working knowledge of IP networks, routing, layer 2 and layer 3 switching, routing protocols such as BGP or OSPF, QoS, VPN technologies, network protocols such as DHCP and DNS
12. Accountable for consulting and delivering highly redundant network services, from design through execution, including a critical role in the creation and ongoing support of the Disaster Recovery Strategy.
13. Maintain network infrastructure and monitoring, including maintenance of component inventory, subscriptions, licensing, lifecycle management and related documentation including physical layouts and logical data flow diagrams
14. Provide technical services and support for the following areas, WAN and LAN connectivity, routers, firewalls, and security, internal systems, cloud, and network infrastructure.
15. Performs network maintenance, upgrades, and refreshes by conferring with vendors, developing, testing, evaluating, and installing enhancements.
16. Responsible for the creation and maintenance of technical documentation to ensure it is updated and current.
17. Configure and troubleshoot network components, routers, switches, VoIP gateways
18. Will also serve as the primary administrator for Cisco Unified Call Manager (CUCM), Cisco Unified Contact Center Express (UCCX), and other telephone systems.
19. Network cable installation and termination.
20. Assists staff in any capacity necessary to accomplish the job of serving the customers of this department.
21. Provides second tier Help-Desk support to end users.
22. Serves as a backup to other Information Technologies staff members as needed.
